Junior Eligibility: Minimum age is 14 years (born in 2004), maximum age 18 (born in 1999) as calculated as of December 31, 2017. Players must be under 19 years of age. Only players born in 1999-2004 are eligible. NO EXCEPTIONS

Proof of Age/Citizenship: Passport proof of U.S. citizenship is required. Only U.S. citizens are eligible to represent our country at the FIRS World Championships.

Team Size: A team consisting of 12 members plus two goalies will be selected. The USARS Hockey Committee reserves the right to adjust team size as needed.

Junior Eligibility: Minimum age is 14 years (born in 2004), maximum age 18 (born in 1999) as calculated as of December 31, 2017. Players must be under 19 years of age. Only players born in 1999-2004 are eligible. NO EXCEPTIONS

Proof of Age/Citizenship: Passport proof of U.S. citizenship is required. Only U.S. citizens are eligible to represent our country at the FIRS World Championships.

Team Size: A team consisting of 12 members plus two goalies will be selected. The USARS Hockey Committee reserves the right to adjust team size as needed.

Additional Team Information: All participants under the age of 18 must be accompanied by an adult for international travel.

Responsibility of World Championship Teams: You will be responsible for the cost of travel from your home airport to the USA Training site, then to the Championship site. The estimated cost to participate is approximately \$1,800, plus airfare (excluding Application Fee; Player fees include the USARS Membership). This fee may be lowered based on fundraising activities. The amount payable to USA Roller Sports will include hotel, on-site ground transportation, travel insurance, Team USA uniforms and Team USA apparel. Additional apparel and equipment may be provided by sponsors.

Application Fee: \$30 must accompany the participation applications.

Deadline for the Receipt of Applications: Monday, Jan 15, 2018 (may be extended by the USARS Hockey Committee). Players will be notified of acceptance by Tuesday, January 23, 2018.

Deposit Due Date: Player has until Friday, Jan. 26, 2018 to accept and make a \$300 deposit to USARS. If a selected player does not make a timely deposit, an alternate player will be contacted immediately and will have 24 hours to accept and make the \$300 deposit.

Teams Posted: Teams will be posted to the USARS website by Tuesday, Jan. 30, 2018.

First Payment Due Date: The first payment of \$500 is due to USARS on Friday, February 16, 2018.

Second Payment Due Date: The second payment of \$500 is due to USARS on Friday, March 16, 2018.

Final Payment Due Date: Final payment of \$500 must be paid to USARS by Friday, June 1, 2018.

Airline Purchase Date: All players must purchase airline tickets (date to be determined) through USARS travel agent unless approved by USARS Hockey Committee.

Passport Requirements: All players must have a passport valid for at least six months beyond the date of departure from Italy.

On Memorial Day weekend, all players must be prepared to attend a Team USA group camp at the location nearest to you (Philadelphia, Southern California or Arizona). Details to follow.
